Annual Ecclesiastical Meeting of Trinity Presbyterian Church (U.S.A.) Cherry Hill, New Jersey February 14, 2021

The sixty-third Annual Ecclesiastical Meeting of the organization of Trinity Presbyterian Church (U.S.A.), Cherry Hill, New Jersey, was called to order by the Moderator, the Reverend Dr. Gregory Faulkner, on February 14, 2021, at 10:30 a.m. The meeting was held virtually on Zoom.

Rev. Faulkner opened the meeting with prayer.

The Clerk declared that a quorum was present.

Rev. Faulkner presented the annual report which had been distributed to the congregation in digital and hard copies for review in January. There being no questions or discussion about the report, the congregation **voted** to receive the 2020 Annual Report as written.

Annual Corporation Meeting of Trinity Presbyterian Church (U.S.A.) Cherry Hill, New Jersey February 14, 2021

The sixty-third Annual Meeting of the Corporation of Trinity Presbyterian Church (U.S.A.), Cherry Hill, New Jersey, was called to order on February 14, 2021, at 10:52 a.m. by the President of the Board of Trustees, Brad Ritchie. The meeting was held on Zoom. The closing prayer of the Annual Ecclesiastical Meeting, delivered by Rev. Faulkner, served as the opening prayer.

The Clerk confirmed to the President of the Board of Trustees, that a quorum was present to conduct the business of the Corporation.

A motion to accept the minutes of the Corporation Meeting of February 4, 2020 was presented by the President, moved, seconded, and **approved** by voice vote.

The President of the Board of Trustees asked Cosmo Digneo, from the 2020 Nominations Committee, to present the slate of new members for the Board of Trustees:

The President called for any additional nominations from the floor. There being none, a motion was made and seconded that the slate be accepted. The motion was **approved** by voice vote.

The President dismissed the Nominations Committee, which consisted of Cosmo Digneo, Rev. Gregory Faulkner, Audrey Azevedo, Donna Croker, Hersch Craven, Doug Nork, Nancy Roberts, and Linda Wean, with thanks.

Audit Committee—Convener Jen Dukelow, presented the report of the 2020 Audit Committee. The Committee included herself, Linda Wean, and Bill Kain and met with Treasurer, Debby Talbott on November 18, 2020, to review the latest updates to the Book of Procedures and perform the 2020audit based on a sampling of financial transactions. Temporary changes were implemented this year because of Covid restrictions. For example, checks normally requiring two signatures, had only one and the second signatory e-mailed their approval. Special care was taken in reviewing the PPP Loan documents and tracking.

The committee reports that the records are accurate, in good order, compliant, and reflect the requirements in the procedure manual. Additional information appears in the committee's report.

The committee once again acknowledged with thanks, the good work, cooperation, and professionalism of Treasurer, Debby Talbott.

There being no questions, a motion was made and seconded to accept the Audit Report, which was **approved** by voice vote. The President dismissed the Audit Committee with thanks.

Mr. Ritchie then reviewed the 2020 financial reports included in the Annual Report. He noted that there was an error in the spread sheet in the "budget vs. the actual columns." Corrected copies are available in the church office. The 2020 budget results and 2021 proposed budget were reviewed and discussed at the January 31, 2021 Budget Forum, and the budget was **approved** by the Session after that meeting.

The President noted that in spite of restrictions on in-person worship, pledge income ended the year on target, while expenses were under budget by \$118,918. The church's cash position is strong. The budgeted transfer of \$52,000 from the investment accounts to balance the books was not required this year. Trinity was awarded a PPP Loan for \$98,300 which was used for payroll, benefits, insurance premiums, and lease payments. This loan was forgiven in November 2020. Our investment holdings increased around 12% in 2020. Mr. Ritchie thanked the finance committee members: Cosmo Digneo, John Young, Donna Croker, and Debby Talbott. He also thanked Trinity's members and friends for their ongoing financial support in this unprecedented year. Follow-up questions were answered.

Mr. Rickie then asked for any Old Business that needed to come before the corporation. Hearing none, he asked whether there was any New Business.

Rev. Faulkner responded that he was informed that in addition to electing new elders as trustees, that the current classes must also be re-elected. The following individuals were proposed to continue serving as members for the Board of Trustees:

While 2021 continued to call for flexibility and creativity, it was a full year serving at Trinity. My days and weeks seem to become more varied and fuller as my time with you continues. This August marked six years that I have been serving here.

I worked closely alongside our PW Moderator and Vice-Moderator to make sure the women of Trinity stayed connected. I lead an online virtual retreat in February on Gratefulness that seemed well received. We had a fun Trivia night for fellowship in the spring along with the spring Installation. It was such a joy to see how dedicated our PW Moderator and Vice-Moderator were to keep everyone connected. In the fall, I once again was able to be a part of the Fall Gathering and preside over our Christmas service.

Along with George Sanders, I continue to co-lead our Stephen Ministry program. We continue to meet regularly with our current Stephen Ministers who are partnered with care receivers, and in November we began a new training with four people who have diligently been engaged with the training once a week. It is exciting to be growing the program.

From January to June, I supported our Deacon Moderator, Doug Nork, as we continued through Covid times. We met regularly virtually, and I was happy to offer any wisdom or assistance as we continued to maintain particularly our mission endeavors. In June, as I transitioned to overseeing our office staff, I stepped away from Deacons, and Greg will help lead them going forward.

I have enjoyed being a part of our Racial Equity committee this past year as we continue to think through moving our church forward in how we can be a part of change for Racial Equity. In June, I lead our first Juneteenth service, a moment to remember the history of the church and our country and a time to dedicate ourselves to continue to do the work required to make sure all are equal. I've tried to offer support for our one church one book study this year that Pat Weikart is so graciously and amazingly leading and make it a priority to attend.

A huge part of my focus over the past year was continuing to keep our children and youth connected from a distance. I touched base monthly with our families through a variety of methods including emails, postcards, and dropping off Holy Week packages to each house. Lisa and I did a Lenten devotional series weekly the month before Easter and sent out boxes of supplies at the beginning. It culminated in a lesson on Easter of Holy Week. I also decided to continue our virtual VBS for a second year. I changed up the format a bit releasing three short videos throughout the week instead of one longer one for five weeks beginning in July and ending in August. I really enjoyed getting a few of our youth involved in two of the dramas!

I worked alongside our Children's Ministry team as we envisioned a new, vital Sunday School program for our children when we came back in the fall. I currently help lead the Family Church Sunday, where we invite the whole family to worship together and help find materials for the 1st-6th graders when they are in worship once a month.

For Youth, we stayed in touch through both Youth Group and Mixers and Mission. We continued to meet over Zoom for Youth Group through the Spring of 2021 and were thankful to switch to in person masked in the fall. We also decided to switch up the program and times a bit to offer more flexibility for all our youth. We now meet once in the afternoon and once in the

evening besides our times of fellowship and mission. Mixers and Mission was also a great way to stay connected.

Through the winter Lisa and I tried to plan creative Zoom gatherings and then in May and through the fall we were able to meet up in person masked. I think the highlight for many of us was a safe Youth Mission trip in July. While it took flexibility and faith on many people's parts, we were able to take eight of our youth to Caldwell, West Virginia in July in the midst of a Covid low. It was hard work, but the adults and youth were amazing- and really handled no cell service well! Organizing it a bit later than usual made it a bit more tricky, but all worked out for a meaningful trip.

I continue to coordinate and teach Commissioning every year. I'm thankful we were able to finally commission our Class of 2020 alongside our 2021 class. While our celebrations had to be altered, I tried to make it special with a surprise Chick-fil-A delivery on the day they met with the session, along with cupcakes, cards from many of our Deacons, and cross necklaces to mark the actual day. We are now back in person masked, and the 8th graders continue to keep me on my toes with excellent questions about their faith and being Presbyterian.

Gen Z was a new idea Lisa and I had in the fall of 2020, and we continued it through the spring and fall of 2021. Lisa comes up with Trivia, and I prepare a few questions that episodes of "The Good Place" or "Ted Lasso" can help us think about our faith and life. Staying connected monthly to our college students near and far has been such a blessing.

Thinking through extending beyond Gen Z, Lisa and I are hoping to gather the 20 somethings in our congregation together a few times a year starting just as fellowship to keep them connected and to check in with them. We gathered with a few in the fall for brunch.

In March when the Goetz's were expecting their second child, I stepped in to help coordinate our BASIC gatherings. We continue to meet over Zoom once or twice a month. We also were able to have an outside gathering in July to see one another.

In June, I took over the role of supervising our office staff. In the fall I began leading the office staff portion of our Tuesday meetings, and I now manage the daily concerns that the office encounters or needs direction on. In general, it has been a smooth transition of me taking over this role. I make sure I am present in the office the majority of the week and keep communication running as smoothly as possible for the team. I coordinated and participated in reviews this year and will fully take over that role this coming year.

After surveying the church on mission interests and hopes for the future, I gathered the elders of the Mission Committee, PW, and Deacons in the spring to collaborate on a Mission statement for us to focus on in the coming years based off the responses received and our history of Mission. The statement approved states, "Through Trinity's Mission and Outreach, we actively seek to ensure all people's basic necessities are met: physical, spiritual, and civil- through engaging with the community in which we live and worship and beyond, with our time, gifts, and voices."

Throughout the last year, I've tried my best to keep our Instagram and Facebook accounts active. Communicating about upcoming events that people are invited to participate in or sharing what has been happening mainly through pictures.

Besides these things I continue to preach about once a month, lead funerals and weddings as asked, meet with anyone who would like care, and cover when Greg is on vacation. I also helped coordinate our Prayer Services and led a few alongside Greg. I put off my continuing education this year since COVID flared up, and I wasn't as comfortable doing a week in person but hope to make that up in 2022.

Outside of Trinity, I continue to take my responsibilities to the larger church seriously. I continue to serve on the Mission Committee for the Presbytery for Southern New Jersey, and I chaired the Programs Committee for Johnsonburg's Board of Trustees. I also was selected to be on the Montreat Youth Planning Team 2022, which required me to shadow a week this past summer as well as beginning to plan for this coming summer. I will serve the last week of July and first of August in 2022.

It was a busy year, but I look forward to seeing what comes in 2022!

Children's Ministries

The Children's Ministries Committee is responsible for the Church School program, from Nursery through the 6th Grade and also oversees the Trinity Nursery School. The committee consists of Gary Naumick, (Session) Chair, Nancy Roberts (Session Member); The Reverend Sarah Craven, who attends each month and helps us plan many activities; Linda Craven, Church School Coordinator; and devoted congregational members Michelle Yeary and Janelle Curl.

Church School 2021

Linda Craven continued to serve as church school Coordinator for 2021. She coordinates the teachers for Nursery thru 6th Grade, secures teacher volunteers, helps select and distribute curriculum, fills in teaching when needed and oversees special projects.

Like many things in 2021, Church School and Trinity Nursery School were dramatically impacted due to the Covid-19 pandemic restricting in-person activities for most of the year. However, through the dedication of Trinity's staff, teachers, and volunteers, virtual programs were developed to continue providing meaningful ministry to the children of our congregation.

Church School: January through August 2021

In-person teaching was suspended during this time due to the Covid-19 pandemic. Pastor Sarah and teacher volunteers provided a virtual program each week. Sarah led a live, interactive lesson via Zoom on the first Sunday of each month. On the other Sundays of the month, volunteer Church School teachers provided a pre-recorded video that children and families could watch anytime. There is a video for children from 3-years old to Kindergarten, and one for Elementary school-age children.

During Lent, Sarah and Lisa Marcelli provided pre-recorded videos featuring crafts and music. Craft materials were delivered in advance to member families. During the summer, Sarah conducted a virtual Vacation Bible School called Compassion Camp geared to pre-school through fifth grade students. Susan Bastnagel provided invaluable video editing support for these programs.

The Children's Ministries Committee would like to thank all those who helped with our virtual Church School program. During this most challenging of years, our volunteers prepared live and pre-recorded video lessons for our children, hand-delivered curriculum and craft materials to our children's homes and learned and mastered new technologies so that we could continue to teach our children about God's love! A big thank you to Pastor Sarah, Superintendent Linda Craven, Susan Bastnagel, Hersch Craven, Jenny Leitinger, Liz Nieradka, Ben Rieth, Roberta Ritchie, Nancy Roberts, and Chris Slusser.

September through December 2021

In-person Church School resumed on Rally Day September 26. Church school is offered for pre-school through Grade 6. Pre-school (starting at 2 ½ years old) through Kindergarten are taught in a single combined class in the main church building. Grade school children are divided into two classes, first-third grades and fourth-sixth grades, and meet in Witherspoon.

Due to health and safety concerns, Nursery care was not offered in 2021.

"New and Exciting" Programs introduced

The Committee used the forced break from the normal routine to develop a new program for our children, which launched in November. A monthly rotation has been implemented, offering more opportunities for families to worship together, and enhancing the connection our children have with Trinity's mission activities.

Highlights of the new rotation include "Mission Sunday" and "Family Church" Sunday. On the first Sunday of each month, grade school-age children meet for a joint lesson and activity in Witherspoon. They are taught a Bible story or lesson that focuses on serving others, followed by a mission-related activity, such as preparing sandwiches for Cathedral Kitchen. On the 2nd Sunday of the month, Sarah leads families in worship in the Community Room in a relaxed, casual atmosphere that will allow families to grow their faith together.

Superintendent Linda Craven has implemented an on-line "Sign Up Genius" portal to coordinate the weekly scheduling of teacher and helper volunteers.

Thank you to all of the dedicated volunteers for their hard work and passion for sharing the love of God with our children!

Trinity Nursery School

Trinity Nursery School (TNS) closed in March 2020 at the onset of the Covid-19 pandemic. It has not been feasible to re-open TNS and meet protocols and regulations for safety in light of Covid-19. The Committee thanks Marina Pappas and her team for their outstanding dedication, caring and professionalism for many years. Many, many children – some now in their 30's, 40's and 50's! – went through TNS, and it was a wonderful part of their development.

The long-term plans for TNS are uncertain. In 2022, the Committee plans to hold a strategic discussion to assess whether TNS can re-open next year in its prior structure, or possibly a new version of a Trinity childcare facility & program could be considered.

Finance and Stewardship Committee

The duty of the Finance & Stewardship Committee is to provide oversight of the Church's Financial activities, investments, and controls consistent with the Church's mission and strategy. The primary responsibilities of the Committee include:

- Preparing and monitoring the operating budget
- Ensuring that proper procedures, practices and controls are implemented to adequately and effectively perform financial transactions and audits
- Monitor and assist with the management of contractual obligations
- Manage the Church's investments
- Administer the annual Stewardship Campaign
- Provide direction to and assist the Church's Treasurer
- Coordinate activities with the Church's board of Trustees and other Church committees
- Provide transparency regarding the Church's financial matters to the church membership

The Finance & Stewardship Committee membership consists of Brad Ritchie – Chairperson, Cosmo Digneo, Vice Chairperson, John Young – Member at Large, Donna Croker – Member at Large and Debby Talbott – Treasurer. Reverend Gregory Faulkner and Pastor Sarah Craven are Ex-Officio Members of the Committee and attend all the meetings. The time commitment and valuable input from each Committee member was greatly appreciated, as significant progress continues to be made regarding financial planning, performance and controls.

The theme of the annual Stewardship Campaign for 2021-2022 was "Connected Now and Tomorrow". John Young coordinated activities associated with the campaign. Treasurer Debby Talbott also provided significant support to the campaign through her management of pledge requests and pledges received. The campaign was enhanced through presentations by Elder Nancy Roberts who spoke about the new approach to our Sunday School program, Elder Alene Bowen spoke about the challenges and accomplishments associated with Trinity's livestreaming at our worship service and Liz Nieradka discussed how our youth are the future of Trinity. Everyone emphasized the impact of stewardship on their connection with Trinity and how additional costs require their financial support. Greg Faulkner was the pastor on Stewardship Sunday (November 21st). Greg preached on the importance of stewardship through his "The Coming Kingdom" sermon.

Throughout 2021, the F&S Committee conducted monthly reviews of Trinity's budget, cash positions, investment results and EasyTithe usage. Detailed reports on income and expenditures are prepared monthly for all Session Committees and organizations. A consolidated report is reviewed by the Committee. At each Session meeting, Trinity's monthly financial information is presented and reviewed by all Session members.

The Finance and Stewardship Committee also reviews funding needs for capital projects and other significant initiatives that may not be provided for in the annual operating budget. The most significant matter addressed in 2021 was the re-opening of in-person worship. Our finances remained strong as our members continued to honor their pledges and the non-pledge income also remained strong. Our recorded services continue to be placed on YouTube and the live streaming of our Sunday services have continued. In order to address some technical issues with the live streaming, we needed to provide funds for the purchase of additional equipment, renovations of a new video control area in the balcony as well as upgrading Trinity's high speed internet capability. These live streaming services will bring our worship services to those who cannot attend the in-person worship services as well as to families no longer in the area. 2021 also saw the reconvening of the Endowment sub-committee.

Trinity maintains several accounts to which donations may be designated – Endowment Fund, Memorial Fund, Manse Reserve Fund, Columbarium Fund and Capital Reserve and Operating Reserve Fund. Monies are released from these accounts to finance Church facility improvements, major maintenance and other Session-approved items.

The 2021 budget year ended with a total income of \$769,873. Pledge income was \$645,906 which was \$17,906 above budgeted expectations. The Committee is very appreciative and thankful for those who have committed their financial support to Trinity's programs, mission and operation during 2021.

Expenses for 2021 totaled \$769,873, which was \$13,458 under budget. The primary reasons for the budget variance resulted from lower snow removal bills as well as having far less program

expenditures due to the pandemic. Additionally, each Committee has performed admirably in controlling expenses through the year.

The 2021 Financial Reports are presented in the last pages of this report. The Session-approved 2022 Operating Budget is also presented.

Membership & PR Committee

The Membership Committee resumed some of its "normal" activities this past year, but with a uniquely 2021 flavor. We held two Membership Information Sessions this past year. The first, in February, was held via Zoom and resulted in six new members. Two more members joined us via Letter of Transfer in the fall. In November, we held the first in-person Membership Information Session since 2019! Seven members joined Trinity following that session. And on December 5, we introduced all 15 of the "Class of 2021" to our congregation. Sadly, since coffee hour is still suspended, there was no cake to share with the congregation in the Fellowship Hall following that service. (We did, however, present each new member with a mini-Bundt cake!)

Rally Day returned in 2021. And while some things looked the same - the signups in the Fellowship Hall and the return of Mr. Softee in the back parking lot – some things were different. Instead of hosting the Rally Day picnic, the Membership Committee provided "Grab and Go" snack bags for attendees.

When the new program year began in September, we resumed the use of the Fellowship Registers. These are instrumental in helping the Membership Committee track attendance trends and follow up with missing members. But what about those watching Sunday services at home?

Trinity currently has 303 subscribers to its YouTube channel, an increase of more than 100 over the past year. Of course, you don't have to subscribe to the channel to view the livestreamed services; in fact, about half of the viewers in the past month have not been subscribers, according to YouTube analytics. A quick glance at those analytics also shows that Trinity's YouTube channel had more than 1000 views from mid-November to mid-December, representing about 350 unique viewing households. And over the past year, the Trinity channel has had nearly 19,000 views. So, while weekly viewership has dipped since in-person worship resumed in June, it continues to be very popular. It's noteworthy that most of our newest members attended virtually long before they crossed the sanctuary threshold in person.

What YouTube analytics can't tell us is WHO is watching from week to week. In an effort to track virtual attendance via livestreaming, the Membership Committee instituted an Online Guest Book. By scanning a QR code, or clicking on a link, viewers can register their attendance, request membership information and/or contact by one of the pastors and leave a comment about the service.

Use of the online guest book is lower than we'd like to see but it does seem to be growing. We will continue to encourage livestream viewers to sign in, just as they would if they were attending church in person. By using our online guest book, you'll help our pastoral staff and Membership Committee know who we are reaching, who we might be missing, and who might be missing us.

Our committee spent some time this past year discussing the role of Courtesy Council. With coffee hour suspended for the time being, Courtesy Council has been dormant. We've discussed whether it's time to reimagine the group's role, which has been largely unchanged for the past decade. Co-chairs Kelly Murray and Audrey Azevedo are taking the lead in this conversation in the coming year.

The Lifetouch Directories were distributed in 2021 – many thanks to Pam Dougherty and Kelly Murray for persevering in that effort! Our committee continues to explore implementing a password-protected online directory. In preparation for that, we requested and received permission from Session to install an SSL certificate for establishing an encrypted link between the FaithNetwork server (which hosts our website) and the trinpres.org site.

We are hopeful that 2022 will bring the return of more Membership Committee events, such as the in-person Nativity Walk (which was virtual once again in 2021), the Christmas Eve Social, and the annual New Member luncheon.

I'd like to express my gratitude to Membership Committee members Audrey Azevedo, Karen Leonard, Kelly Murray, Mike McBride, and Meghan Craven, and especially to Membership Associate Pam Dougherty. Each of you brings so much to the Trinity community. Your insights and assistance have made my job much easier this past year and I'm grateful.

Mission & Outreach Committee

Through the efforts, faith and generosity of our Trinity Presbyterian Church family, our mission and outreach activities continued to grow in service to the community.

Mission Thursdays continued this year. Trinity members and friends supported Cathedral Kitchen, Cherry Hill Food Pantry, R&M Boarding Home and other local organizations through a safe and contact-free collection site in our Trinity Parking lot. During 2021, we donated well over 10,000 sandwiches, almost 6000 bottles of water, over 500 bags of fruit and over 250 bags/boxes of snacks to Cathedral Kitchen. In addition, we donated over 7,000 pounds of food and supplies to the Cherry Hill Food Pantry. Presbyterian Women and Deacons also partnered with us for Mission Thursdays collecting items including personal care items and clothing for R&M Boarding Home guests, along with winter coats and food for organizations like Urban Promise and Acenda Health.

In addition to Mission Thursdays, Trinity supports Cherry Hill Food Pantry through volunteering and distributing food to residents in need. Despite the pandemic and a required move to a new location, Cherry Hill Food Pantry continued their vital services to the Greater Cherry Hill community uninterrupted throughout 2021, as people experiencing food insecurity in our community also continued to rise.

Our committee also sharpened our focus on justice issues, with a particular emphasis on racial equity. We worked with the pastoral staff to assist with hosting town halls around racial justice and have begun a program-year long book study on How to Fight Racism by Jemar Tisby.

CROP Walk to stop world hunger returned in October 2021, raising \$1648.05 to fight hunger. A quarter of that was donated to Cherry Hill Food Pantry, with the balance donated to Church World Service to combat hunger.

Friends of The Carpenter, BookSmiles, an Adult Mission Trip continued to be paused due to Covid-19 in 2021, but we hope for those efforts to resume in 2021. Rev. Craven and advisors were able to organize a summer mission trip and take eight of our youth to Caldwell, West Virginia in July in the midst of a Covid low.

In addition to coordinating and overseeing volunteer and justice mission activities, Mission and Outreach is charged with distributing a portion of the benevolence money received via your tithes and offerings to both local and global missions. Our giving for the past several years has focused on supporting refugees, clean water, food ministries, and women's ministries. Details of our giving for 2021 can be found below.

Board of Deacons

According to the by-laws of our Church, the Board of Deacons is comprised of men and women who serve three-year terms. Deacons serve on a rotating basis, with eight new Deacons being ordained each year and eight Deacons rotating off the board. The Deacons are responsible for service, fellowship, visitation and outreach to the congregation and to the community. The Board of Deacons meets on the second Sunday of each month from September to June.

Due to the COVID-19 Pandemic, the in-person meetings of the Board of Deacons were and at present, suspended but are being conducted virtually.

All Deacons share certain responsibilities. These duties include preparing and hosting coffee hour throughout the year, delivering flowers to homebound church members, and assisting in various parts of worship services. More specific duties are fulfilled through Committee assignments. Once again, the pandemic has affected our responsibilities since March 2020 with in-person worship. There has been no coffee hour, flower deliveries and assistance in various parts of worship services. We will, however, resume all normal responsibilities when in-person worship becomes safer for everyone.

The Service Committee

The Service Committee is responsible for the setup, breakdown and cleanup of Communion. At Trinity, Communion is held on the first Sunday of every month as well as on special days (like Christmas Eve). The Service Committee also coordinates the Sunday ushering teams. Various groups within the Church will also "adopt" a Sunday for ushering. For the months of December and April, special teams usher for the entire month. This has been a practice at Trinity for many years.

The following changes were facilitated to enable "In Person" Worship:

Communion: The use of bread and juice trays have been replaced by Communion Kits which contain a wafer and juice. This is so that germs are not spread through the passing of platters through the pews. These Communion Kits are made available by the ushering team on duty.

Ushering: Ushers still arrive at around 9AM for Regular Services and about 8:45AM for Communion Services to allow time for setting up C-Kits and napkins in the Narthex. A minimum of four ushers is recommended as the Congregants are escorted down the center aisle and asked if they prefer the Pulpit side (non-distanced) or the Lectern side (socially distanced). The Lectern side has had every other row roped off.

At this time the Membership Committee is not providing Greeters at the door, so the ushers set out the Visitors Logbook and are constantly on the alert for unfamiliar faces. Also, the ushers must be vigilant to spot unmasked individuals and provide them with masks. The hearing devices are working now and are cleaned at the end of the service, if used.

The ushers are still conducting a head count and the Offering Plates are set out on either side of the Narthex for the Congregants' use either while entering or leaving the Sanctuary.

The Fellowship Committee

The Fellowship Committee coordinates Sunday coffee hour each week. They sign up the volunteers, send them reminders and oversee the procedure. This Committee is also responsible for keeping the supplies in the upstairs kitchen inventoried and stocked appropriately. The Fellowship Committee is also available to assist with other fellowship opportunities within the Church when needed. As of March 2020, the coffee hour was suspended due to the Covid-19 pandemic.

The Visitation Committee

The Visitation Committee coordinates weekly flower deliveries to our church members who are sick, homebound or grieving as well as for celebrating joyous occasions. Each week a flower bouquet is delivered with a small card wishing the recipient well on behalf of the Church. This Committee also coordinates the delivery of holiday flowers, usually at Easter and Christmas, to homebound Church members. Due to the pandemic, our flower deliveries have been temporarily suspended since mid-March 2020. Our last flower delivery was on March 7, 2020. We have been unable to deliver flowers since then and hope to resume as soon as possible.

The Assistance and Outreach Committee

Martin Luther King Oratory Contest-February 12, 2021 The Deacons supported the contest and Barb Clarke volunteered to be a judge. The contest was done virtually, and video clips of each student were sent to the judges. The cost (\$187.07) for the Target gift cards used as prizes came from the Deacon's fund.

Blood Drive- On April 26, 2021, 23 productive donations were collected as well as 2 power reds which are red blood cell donations. This helped 69 hospital patients in need.

Summer Sharing Food Program- The Deacons purchased food and home goods for Urban Promise, Acenda Health, and the Cherry Hill Food Pantry. Date of delivery was June 19, 2021. The amount, \$2100 came from the Deacon fund for the items.

School Supply Collection- Using the same model as 2020, we piggybacked off the Mission and Outreach Committee's Mission Thursday collections (every other Thursday) and added a drop-off in the Narthex during Sunday's services. Beginning on August 5th and running through September 30th, our congregation dropped off their donations of school supplies. We delivered all school items to Urban Promise.

Fall Coat Drive for Kids and Families- Again as in 2020, we piggybacked off the Mission and Outreach Committee's Mission Thursday collections (every other Thursday) including drop-off in the Narthex during Sunday's services. Starting on September 30th through December 2nd, we collected Adults and children's coats (new or slightly used) from our congregation. The coats were delivered to R&M Boarding Home (specific list of gender and sizes supplied from R&M), Cathedral Kitchen (all remaining adult coats) and Little Hands/Little Feet (all children's coats), a committee from St Andrews's Methodist Church.

Blood Drive- Our fall blood drive was held on November 1, 2021. 24 productive donations were collected including 3 red blood cell donations. This helped 72 hospital patients in need.

Christmas Sharing Food and Gift Program- Continuing as last year, we piggybacked off the Mission and Outreach Committee's Mission Thursday collections (every other Thursday) and drop-off in the Narthex during Sunday's services. Thursday collections were November 11th, December 2nd, and December 16th. We used the church's social media sites to send the information out for the gifts and the collection dates. The gifts were delivered to two groups Urban Promise (December 10th) and Acenda Health (December 17th). The food and household items were purchased from ShopRite of Cherry Hill and were received on December 16th. The items were divided into three groups and delivered on December 17th and December 21st. The groups were Urban Promise, Acenda Health and Cherry Hill Food Pantry. The Deacon's fund spent \$2,700.00 for the food and household goods plus \$390.00 for the remaining Acenda Health Gift Cards.

Care 'n Share Mission Outlet, known now as the Care 'n Share Thrift Shop, started in 1976 as a clothing drive. There were so many donations that the Presbyterian Women's Board thought that a thrift shop could benefit the general public and the profits could be donated to local missions and charities. With \$100 seed money from Trinity's Session, the women opened the shop in the basement of Westminster House (the old office).

Their first donation of \$1,000 was given to the Scholarship Fund at Presbyterian Hospital, Licensed Practical Nursing Program in Philadelphia. Over the years the focus of the donations has changed. They now go to food and shelter programs for families. In recent years, we had been giving about \$20,000.00 a year to various organizations.

Because of the Covid Pandemic (March 2020) we were closed for 18 months, but were able to re-open in September 2021, with volunteers and customers wearing masks.

In the 3 months that we were open in 2021, we were able to have sales of approximately \$5,000. (See Care 'n Share Financial Report in Annual Report)

The shop with its "garage sale" prices is a mission, offering quality, gently used clothing, house wares, books, toys, etc. Most of the items come from Trinity's members. Our hours are Tuesdays, Thursdays & the "first Saturday" of the month from 10 am. to 1 pm. from September to June. (The shop is now housed in the "newer" basement since 2001.)

The shop is totally manned and managed by Trinity volunteers. Personnel Committee

Committee members for the 2020-2021 Church year were seated Elders John Young '21, who served as chair, Elder Peter Bowman '22 with at-large members Nancy Valente '23, Anne Marie Palatnik '22, and Elder Janet Cohen '21.

Much of the work of the Personnel Committee (PC) is, by its nature, confidential. During 2021, Trinity was blessed to have a dedicated staff who continued to serve our congregation with passion, dedication and faith during the challenges of the pandemic.

Our Senior Pastor, The Reverend Dr. Greg Faulkner continues to lead, inspire and guide our congregation with the help of our clergy, office staff and volunteers from the congregation. His management of these essential resources has been critical for maintaining Trinity's vital ministry and morale during the pandemic. During most of 2021, Greg spent a large portion of his time remotely connecting with Church members to address their concerns and challenges during the pandemic. He also worked with his Church team and Session as they conducted necessary Church activities, conducted in-person and live-streamed worship and strategically addressed issues associated with the pandemic.

For the 2020-2021 Church year, the Personnel Committee established performance goals for Reverend Faulkner in the following areas:

- Preaching and Worship
- Teaching Ministry
- Stewardship
- Leadership of Staff and Lay Leaders
- Leadership Development

To help achieve these goals, Greg dedicated one day per week to solely studying for sermons and educational offerings, supported the Racial Equity discussion groups, initiated a weekly Bible study of the Gospel of John, worked with the Whole-Life Giving Committee to develop education material dealing with support of Trinity through estate planning, increased his time spent with Church staff and Session members, and developed mentoring relationships with younger members of the Church.

Our Associate Pastor, The Reverend Sarah Craven, continues to support Greg and Church members, particularly through her work with our youth. During the pandemic, she has been very active on social media supporting Church activities and Children's Education. For the 2020-2021 Church year, the performance goals were established for Sarah in the following areas:

- Connection to Trinity Members and Community
- Children's Ministry
- Mission
- Leadership Development
- Personal Training

To achieve these goals, Sarah met with Trinity's college students, maintained a visible and active social media presence, lead and participated in virtual Sunday School lessons, revamped the 2021–2022 Sunday School program with the support of the Children's Ministry Committee, and helped develop a mission strategy for the Church.

We continue to be grateful for the ministry of Reverend Barry Gruver, who serves as our part-time Parish Associate. Rev. Gruver primarily provides our parish outreach services, supporting the sick and elderly in both hospitals and rehabilitation facilities. Unfortunately, during the pandemic, this pastoral ministry had to be performed remotely. Additionally, Barry was unavailable for several months due to health issues. Fortunately, Barry returned for the 2021-2022 Church year to assist in our worship on most Sundays. Session has recommended him for another annual term, and we look forward to his ministry in 2022.

We are very grateful for the enthusiasm, creativity and energy of Lisa Marcelli, our Music Director, and Brian Kain, our Music Associate, as they work with our children's choirs, adult choir, hand bell choirs and instrumental groups. While the activities of the choirs have been severely restricted during the pandemic, Lisa has maintained contact with most music program participants. Given the limited music options available for virtual worship services, Lisa and Brian provided the entire music support for most of these worship services. With the initiation of in-person worship, Lisa has creatively developed music for worship that has been compatible with the pandemic restrictions. She continues to engage the middle and high school students within the congregation through the vibrant Mixer & Mission activities.

Our dedicated office staff continues to admirably support our clergy and congregation. Sue Nork, our Office Manager, works full time managing and performing numerous office functions with the assistance of Media Associate, Alysia Badskey, who works 2 days per week. The Membership Associate, Pam Dougherty, also works 2 days per week supporting the Membership Committee and helping with visitor documentation and pastoral ministry. Our Treasurer, Debby Talbott, is another trusted full-time member of the office staff. With the help of the Finance & Stewardship Committee, Debby manages the day-to-day financial issues and investments of the church. During the pandemic, many of the office functions were conducted remotely. The Personnel Committee encourages staff to seek opportunities that contribute to their professional and personal growth.

During 2021, the Personnel Committee, working with the pastoral staff, modified the responsibilities of Reverends Faulkner and Craven. To provide Greg more time for pastoral care, teaching ministry and mentoring, direct supervision of the office staff was transferred to Sarah. Greg also assumed responsibilities for Deacons. To date, the transition of responsibilities and associated performance has progressed admirably.

The PC is also responsible for providing staff with the resource they need to effectively and efficiently perform their responsibilities. Frequently, this involves technology upgrades. After a significant assessment of the office technology capabilities in 2020, significant upgrades were completed last year. In 2021, system upgrades were limited to providing additional computer network storage capacity.

Property and Buildings Committee

The Property and Buildings Committee reports to the Session with the primary responsibility of managing the use and maintenance of Trinity's facilities. The committee oversees the following for all church buildings and grounds:

- 1. Property budget
- 2. Repair and maintenance
- 3. Service contracts including:
 - a. janitorial services, maintenance services, landscaping, exterminating, snow removal, trash removal, and equipment servicing
 - b. all mechanical equipment including elevators and fire alarms, heating, air conditioning, and kitchen appliances
- 4. Purchasing of maintenance equipment and building supplies
- 5. Utility usage monitoring and conservation
- 6. Building use requests

In 2021, we remained ever vigilant of the Covid pandemic and the potential effects on our church life and the health and wellbeing of the congregation. In response, we maintained the session guidance for seating distance and mask guidance and modified the sanctuary air circulation system to increase fresh air intake by an estimated 30%. This led to new initiatives to enhance staff safety, building security, virtual communications capabilities and ongoing items required for maintaining our church property.

The following is a list of the projects/activities for 2021.

- 1. Summer and fall landscape maintenance [weeding, trimming, and mulch] was performed by our contractor [H+H] to supplement the volunteer plot programs impacted by Covid.
- 2. The Adopt-A-Plot program was re-invigorated [with the help of Pam Dougherty]. We are hoping that this will reduce on needs from our landscape contractor going forward.
- 3. The boiler system was serviced and repaired to maintain proper heating to the sanctuary.
- 4. Air filters for roof HVAC units servicing the Office, Witherspoon building, and the Sanctuary were replaced.
- 5. All roof top HVAC units were inspected and serviced to maintain good working order for these 21+ year old units.
- 6. Various repairs were made to lighting, toilets, sinks, doors, locks, and windows.
- 7. Additional LED fixtures were used to further upgrade existing parking lot lighting. This provides improved lighting for security and energy saving.
- 8. The lighting system in the church sign along route 70 was repaired.
- 9. New LED lighting was added for Steeple illumination to replace the existing lighting that had failed.
- 10. In coordination with the Technology Committee, a new production center was designed and installed to provide a permanent setting to support the Live-Streaming capabilities of the church.
- 11. We completed our investigation into a new service provider for our Fire Alarm and Sprinkler systems and issued a new service contract.

These tasks are often simple little projects that are done by the committee and volunteers. If anyone would like to donate their time and talents to help tackle some of these simple "to do" list

projects, contact anyone on the P&B Committee and we'll be glad to share our list with you and appreciate your assistance.

Due to Covid restrictions and safety concerns, Session voted to minimize all church property uses and reviewed each application before a vote. Waivers were granted to AA for the continued use of Witherspoon and to the Boy Scouts for outdoor program uses.

Solar Panel update - The Solar project, which became operational on June 26, 2018, continues to provide benefits.

In addition to the "evergreen" project list generated and updated for the repair and maintenance of our facilities, the following Capital projects are being investigated for 2022:

- 1. Steeple repainting [Tower, Belfry and Spire]
- 2. HVAC replacement for the new building [in conjunction with the NJ Energy Programs]
- 3. Various projects as indicated in the NSGP [Non-profit Security Grant Program] as awarded by the NJ Office of Homeland Security

The Property and Buildings Committee is comprised of three ruling Elders; Jay Reinert, Dave Large and Committee Chair Rick Fletcher. We are supported by at large members including Walt Steinle, Bill Strobel, Tom Tilsner and Rich Fletcher. Chris Bryfogle continues to assist with evening energy walk-throughs.

I am very grateful to each of them for their continued dedication and service to our church. Trinity would face many additional challenges without their ongoing support and expertise.

Thanks also to the many volunteers who helped with the security and communication projects, the various clean ups, small projects, decoration events, and consultations on technical matters. A special thanks to Sue Nork and Pam Dougherty for all they do to drive and support us.

Strategy Committee

The Strategy Committee was formed in 2012 to address issues associated with the short- and long-term strategy of the church. When implementing and reviewing this strategy, the Committee considers all aspects of our life together, including worship, education, stewardship, growth, and mission. The committee is guided by the Trinity mission statement: "An Inviting Community Serving Christ for Life. Loving God, Welcoming All, Helping Many"

The Strategy Committee consists of the chairs of each of the Session committees and the Clerk of Session. This structure allows all areas of the church to have input into our strategic direction. This approach also provides the diversity needed to properly prioritize initiatives and resources.

The committee may also provide input to:

- Session committee responsibilities
- Financial and personnel issues
- Stewardship campaign
- Budget creation and adjustments
- New or revised fiscal and administrative policies

During 2021, the activities of the Strategy Committee were significantly restricted by the pandemic. The committee was involved with the decision to stop in-person worship in March 2020 to protect the health and safety of our Church members. In the Spring, 2021, the Committee developed a "reopening plan" to assist with the return of in-person worship. The Committee also developed an approach to address issues associated with the proposed construction of a Wawa store adjacent to the Church.

In compliance with Trinity's Capital Investment and Expenditure policy, the Strategy Committee is also responsible for reviewing, prioritizing and approving all church capital expenditure. During 2021, the following capital expenditures were reviewed and approved by the Committee:

- Construction of permanent livestreaming facilities in the Sanctuary balcony with additional video and audio production equipment, computer upgrades and improved Sanctuary lighting.
- Increases to the computer network storage capacity in the Church Office
- Cost-effective changes to Trinity's service provider that inspects and services the Church's fire protection systems
- Replacement of a portion of the flooring in Witherspoon

January 2021 found the TPT in a holding pattern due to Covid restrictions. In February we were able to resume training of team members on camera, text and audio operations. As team members became comfortable with the systems, they began running the services each week. The team uses Signup Genius to schedule themselves.

It was hard to believe that in March we were at the one-year mark since Covid began. The first year was a very steep learning curve but as we reflected over the past year, we were amazed at how much we had learned and how much had been implemented. All of us on the team could feel the Spirit guiding us.

Before we knew it, it was Lent and we were facing another Easter Season of completely virtual worship. Thanks to the fabulous worship team and office staff, TPT was able to produce both meaningful and high-quality Lenten and Easter services.

In June of 2021, we very excitedly welcomed back our Trinity family to in-person worship services, and it was a joy to have other people in the sanctuary once again as a community of faith. Now we could happily report that Trinity was offering both in-person and virtual worship.

Burt and Alene were able to take some time off during the summer months while the team handled the running of services which was a welcome break for us.

Weddings/Funerals: In 2021 we livestreamed and/or recorded two weddings and one funeral service which were learning experiences for us. With each one, we are learning new ways to make these special services better.

As we approached our one-year livestreaming anniversary in November 2021, we were feeling much more confident in the systems in place. Our goal for 2022 is stability and consistency.

This was also our second year of producing Advent and Christmas services. We feel that we learned a lot last year that helped provide meaningful services for everyone this year. Many thanks to Lisa Marcelli and Brian Kain for the beautiful music they, along with our choirs and musicians, provided to make this season special. To all the folks who were part of rehearsals with the production team, thanks for your patience and professionalism.

With capital funds we have been able to acquire some new equipment that has helped make worship better for both in person and virtual worshippers. A new transmitter was purchased to fix our Assisted Listening Devices. We have received feedback from members that this has been a great improvement for them in their ability to hear the worship service more clearly. The migration of the sound system from the floor of the sanctuary to the balcony production area was completed. It is very efficient to have all production systems together in one place.

The build-out of the production area has been completed with the help and work of the Property and Buildings Committee and Walt Steinle. Many thanks to those folks who have helped us create an organized, dedicated production space that should serve Trinity well for many years to come. If you haven't seen the production area yet, please feel free to stop by after worship and check it out.

Finally, a huge thanks to Burt Bowen, Joe Azevedo and Susan Bastnagel for all the hours they put in and the work they do behind the scenes to make sure Trinity can reach a worldwide audience. It has been gratifying to learn that we have added new members that first came to Trinity through our virtual offerings. We are all very thankful for the support and prayers we have received from our congregation.

We ask for your continued prayers for the production team as we seek to spread God's love in this new ministry.

Worship and Music Committee

The Worship and Music Committee of the Session (W&M) provides general oversight of Trinity's worship services and music program. In 2021, the committee once again consisted of Elder Steve Talbott (chair), Elder Janet Cohen and at large member Bonnie Jones. The committee meets on a regular basis with Director of Music Lisa Marcelli and the Rev. Dr. Greg Faulkner throughout the program year.

Some of the other duties of the committee include reviewing Baptism requests and recommending to Session for approval as well as setting communion dates and making sure they receive Session approval. In addition, although it has been suspended during Covid, the committee also manages the assignment of Elders each month to serve communion and to greet at the front door during Sunday morning worship services. Also suspended during Covid is the weekly signup of Sanctuary Flower memorials and ordering of arrangements from a local florist. We are hopeful that 2022 will allow for the return of flower memorials and monthly communion served by Elders.

2021 began with a lot of uncertainty as to when Trinity would finally be able to move towards some sense of normalcy with the hope and anticipation that we could soon return to in person worship. It was very helpful (for planning purposes) that I had a role as a member of the Ad Hoc Opening Committee so that W&M was able to participate in the details of the return to in person worship and have timely information on what was being discussed by the Ad Hoc committee. We were excited to welcome the congregation back to in-person worship in June!

Many thanks to Brian and Lisa for their hard work and adaptability as they had to re-invent the best way to present music virtually. The spring Children's Musical was a production of Noah and it involved a totally virtual service that was all pre-recorded. Brian became an instant expert in recording and editing of sound and video!! He and Lisa recorded audio and video clips of all of the kids' performances and then put it all together for insertion into the service by Susan Bastnagel.

Lisa also found that she needed to do some research to understand the requirements for Streaming Licenses for music that is included in the Live Stream Services. You'll notice the music credits each week that are posted at the end of the service. We are grateful that Lisa is diligent about Trinity being compliant by making sure that we have adequate permission to perform each piece of music every week. In some cases, she has had to reach out to the composer for permission if the piece is not included in the two streaming licenses that Trinity has purchased.

Some other unique challenges to the return to in person worship include:

- Communion returned on July 4th with the use of individually packed communion elements. We were concerned with how difficult they might be to open, especially for the elderly members.
- Sanctuary Flowers- Many thanks to Pam Dougherty for preparing the silk arrangements to beautify the sanctuary during worship until we can once again have live arrangements.
- Worship Greeters/ Ushers- Thanks to Doug Nork and the Deacons for taking on this important responsibility!
- Hymn Singing- initially, there was no congregational hymn singing but that restriction was eased by Session in July with a limit on number of verses.
- Choirs- It was great to have the return of the Adult and Children's choirs in the fall even though they all had to get used to singing with masks. We were pleasantly surprised that the quality of the sound was pretty good and there was great participation from choir members of all ages.

Trinity Community Concert Series- The 2021 TCCS Season (which ran from fall of 2020 to spring of 2021) was cancelled due to Covid. The 2022 season began with a Christmas Concert on December 3rd by the Atlantic Brass Band. There was a great turnout, and everyone was excited for a return to live music at Trinity! The Barbone Street Jazz Band is scheduled for March 2022 as the 2nd concert of the season.

Lisa hired Julia Wilson as an accompanist for the children's choirs and she began in the fall with the start of the program year. Lisa has been wanting to hire an accompanist for some time but wanted to make sure it was the right person. We are all excited that Julia is on board and working with Lisa and our young musicians!

As a committee, we remain grateful for the Staff and Volunteers at Trinity that work so hard each week to provide our congregation with a meaningful worship experience. We are especially appreciative of Lisa and Brian for their ability to be flexible and provide a variety of quality music each week despite the Covid restrictions. Of course, we couldn't be a vibrant congregation without the spiritual leadership of Greg, Sarah and Barry who have also been flexible in their approach to worship during the pandemic. We are very blessed as a congregation to have such a quality pastoral staff that works hard to meet and exceed all of our spiritual needs! Special thanks to the Trinity Production Team- Alene and Burt Bowen and their team of volunteers as well as Susan Bastnagel who make sure that every service is live streamed in a quality manner each week. Thanks also to the volunteer greeters and ushers that are needed each week to make sure that we comply with our return to worship guidelines.

As we look towards 2022, we are hopeful for a continued transition to post Covid normalcy and pray that God continues to bless Trinity Presbyterian Church!

Youth Ministries Committee

Commissioning Class:

Under the guidance of Rev. Sarah Craven, Barb Clarke and Meg Warren, the 7th and 8th graders of Trinity studied in preparation for becoming members of Trinity Church's congregation. Through the commissioning program, the 7th graders focused on the book of Luke. Rev. Sarah also led Bible overviews as well. There were eight 7th graders that attended Commissioning Class this past year. In May 2021, there were five 8th graders and three freshman that became members of Trinity.

Sarah Craven participated in a socially distanced gathering to start off the new year. The commissioners also helped pack care packages for the college students of Trinity. Senior High Fellowship:

The Rev. Sarah Craven continued to lead the Senior Highs serving as the Youth Director. Rich Fletcher and Tracy Miller also served as year-round advisors, with Donna Allen continuing to serve and support the Senior Highs with key events, along with Steve Morton who led small groups on our work trip. The Senior Highs completed various activities, including a mission trip to Colcord, West Virginia.

The Senior Highs met via Zoom from January through June. The start of the school year included a socially distant experience to reconnect with the youth. Since then, we have met in-person and masked. We have tried to switch up our program to include afternoon and evening meetings.

Mixers and Mission:

Mixers and Mission was led by Rev. Sarah Craven and Lisa Marcelli, who were able to continue the charge of sparking mission in our youth despite the challenges of meeting in a safe environment. The students participated in various activities including making blankets for the Linus Project, a "Chopped" Peep challenge, donation of books for Book Smiles and our annual Scavenger Hunt. The fall activities included the CROP Walk where they were encouraged to invite a friend and assisting with the Hanging of the Greens.

Gen Z

Rev. Sarah Craven and Lisa Marcelli continued to connect with the college-age students of Trinity through "Gen Z." The group met monthly via Zoom to finish analyzing and discussing the TV show, "The Good Place" in the spring before beginning the TV series, "Ted Lasso" in the fall.

The Youth Ministries committee is grateful for those who give their time and gifts to the youth of Trinity. We are proud of the accomplishments of our youth and look forward to what the future holds. We pray that we continue to serve God and the youth in a manner that positively impacts and helps support our youth, Trinity Presbyterian Church and our surrounding community.

2021 Audit Committee

The Audit Committee for Trinity Presbyterian Church (USA) elected at the Annual Corporation meeting consisted of Jen Dukelow, Bill Kain and Linda Wean. Using the Audit Steps template developed by the 2013 Audit Committee, the 2021 committee met with Treasurer Debby Talbott on October 19, 2021, to review the latest updates to the Book of Procedures and perform the 2021 audit based on a sampling of financial transactions from the current year.

The Book of Procedures used to implement the financial policies of the Church were reviewed and approved by the Stewardship and Finance Committee on October 7th, 2021. This was verified by the Audit Team.

Counter results, check deposits and bank statements were provided for the following months and dates January 28th, April 22nd and June 17th of 2021. These reports were reviewed and there were no discrepancies or inconsistencies found.

A review of all payroll documents was done for payroll periods in the month of June 2021. This included checks sent to the IRS for withholding taxes. The records also audited included employee timecard, net pay, payroll taxes paid to the IRS and employee pay stub. The documents were correct, and all verified to the proper accounts.

Audit Easy Tithe receipts for May 2021 matching bank deposits and tying into the total for the month. There were no inconsistencies or discrepancies found during the audit.

The Memorial Fund and Endowment Fund Review of Investments for the month of September was completed. There were no inconsistencies or discrepancies found during the audit.

An audit was performed on all checks over \$2000.00 for the 2ND Quarter (April, May, and June). This audit included confirming the inclusion of double signatures as required by Church policy (confirmation by email in lieu of two signatures used when needed to follow COVID-19 guidelines).

All credit card bills for the month of May 2021 were reviewed in accordance with the Book of Procedures. Each charge had the required voucher and receipt/billing invoice to appropriately charge the correct budget line item.

All current contracts were reviewed and found to be in order with Trinity's procedures on requirements, approvals, and routine tracking to ensure continuity of coverage by the terms of each contract.

Review of the Property and Liability Insurance Policies in force as of July 31, 2021, to prove conformance that the limits are in line with the asset values listed in the financial statements as of December 31, 2020.

This Committee, as always, appreciates the contributions of Debby Talbott in maintaining and preparing the materials needed to perform the annual audit.
